Once you begin completing the form, you can **save and return to your application** at any time using the facility provided. Upon completion, you will also be able to **print or save a copy** of your application.

There is currently no set deadline for completion of this Stage 1 form. However, we cannot guarantee your application will be processed should the Fund be oversubscribed. ACRE will process applications in order of receipt.
